How to Change Your Address

Where do I begin?
On the left navigation bar begin by selecting Name Search or Map Search to find the property for which you wish to request a change of billing address.

Is the change immediate?
No, the change is not immediate. All changes are made by hand after being reviewed.

Why can't I change the owner name?
Changing anything other than the billing address requires a change of the deed.

Will this affect my 911 address?
No, this only affects the address where this property's tax bill is sent.

What happens after I submit this form?
After the form is submitted it will be reviewed by someone in our treasury office, before the change is authorized.
