Sealed bids will be received on behalf of Sussex County, (herein called the "OWNER") at the Sussex County Department of Emergency Medical Services Paramedic office located within the Sussex County Administrative West Complex, 22215 DuPont Highway, Georgetown, Delaware until 3:00 pm., local time, on Wednesday **August 3, 2016**. Immediately following, they will be publicly opened and read aloud in the Sussex County West Complex Administrative Complex large conference room for the following project:

**State of Delaware wage rates may apply on this project. Therefore, the Project will be bid with and without prevailing wage rates, and these requirements will be further discussed at the mandatory Pre-Bid Conference.**

EST.** in the West Complex Administration Building, 22215 DuPont Highway, Georgetown, Delaware, to allow Contractors an opportunity to obtain information on the project from the Consulting Engineer and the OWNER. The OWNER reserves the right to extend the time and place of Bid Opening on not less than two (2) calendar days notice by certified delivery, electronic delivery, or facsimile. Failure to attend the Mandatory Pre-Bid Conference shall result in the Bid being unopened and returned to the Bidder.
