

INVITATION TO BID

Sussex County will receive sealed bids in the County Council Chambers, Sussex County Administrative Office Building, 2 The Circle (P.O. Box 589), Georgetown, Delaware 19947, until **10:30 a.m., local time, on Thursday, May 26, 2016**. Immediately following, they will be publicly opened and read aloud for the following project:

CONTRACT TERM: 30 CONSECUTIVE CALENDAR DAYS

Bids are being sought from contractors to provide all labor, materials, equipment, and services required for the **TAXIWAY B (W) AND ASPHALT TIE-DOWN APRON (N) REHABILITATION** project. The project mainly consists of rotomilling, installing a pavement fabric interlayer, and paving of the existing asphalt overlay on the concrete taxiway and tie-down apron pavements. The Work shall also include, but not be limited to, maintenance and protection of airport traffic and pavement striping.

Each Bid must be accompanied by a Bid Guarantee equivalent to ten (10) percent of the amount of the base Bid and all alternates. The Bid guarantee may be a certified check or a Bid Bond secured by a surety authorized to do business in Delaware. The Bid Guarantee shall be made payable to Sussex County Council. A Bid Bond shall be submitted in the format attached hereto.

A **MANDATORY** pre-bid conference will be held at **10:30 a.m., Wednesday, May 11, 2016**, in the County Council Chambers, Sussex County Administrative Office Building, 2 The Circle (P.O. Box 589), Georgetown, Delaware 19947, followed by a site visit. Bidder's failure to attend the mandatory pre-bid conference shall result in the rejection of its Bid.

No scale wage rates are applicable on this project.

Sussex County reserves the right to alter the time and place of the Bid opening on not less than two (2) calendar days' notice by certified delivery, facsimile or other electronic means to those Bidders who obtained copies of the plans and specifications. Sussex County reserves the right to waive irregularities and reject any or all Bids.
