#### Administrator's Report

Mr. Lawson read the following information in the Administrator's Report:

1. Advisory Committee on Aging & Adults with Physical Disabilities for Sussex County

The Advisory Committee on Aging & Adults with Physical Disabilities for Sussex County will hold a special meeting on Tuesday, February 11, at 9:30 a.m. at the Sussex County West Administrative Complex, 22215 North DuPont Boulevard, in Georgetown. A copy of the agenda is attached.

2. Delaware State Police Activity Report – December 2013

Per the attached Delaware State Police activity report for December, there were 3,443 total traffic arrests and 1,286 total criminal arrests. Of that 1,286, 484 were felony and 802 were misdemeanor criminal arrests. Of the total hours on duty spent, 41 percent were spent on criminal investigations.

3. Sussex County Emergency Operations Center Call Statistics – December 2013 and Year-End Totals

Attached please find the call statistics for the Fire and Ambulance Callboard for the month of December and 2013 overall. There were 13,186 total calls handled in the month of December. Of those 9-1-1 calls in December, 77 percent were made from wireless phones.

In 2013, there was a small decrease in the number of 9-1-1 calls handled, as opposed to an increase in the number of incidents dispatched. 9-1-1 calls decreased from 107,388 in 2012 to 106,058 in 2013, but the number of cellular generated 9-1-1 calls increased from 81,211 in 2012 to 81,777 in 2013.

Total incidents dispatched increased from 29,350 in 2012 to 30,148 in 2013. Of the 30,148 incidents dispatched, 4,638 were fire incidents and 25,510 were EMS incidents.

Legislative Update

Hal Godwin, Deputy County Administrator, provided the following legislative update:

**Senate Bill No. 6** – "AN ACT TO AMEND TITLE 19 OF THE DELAWARE CODE RELATING TO THE MINIMUM WAGE".

Legislative Update (continued) Synopsis: This Act would increase the minimum wage to not less than \$8.00 per hour effective July 1, 2013, and not less than \$8.75 per hour effective July 1, 2014. If the federal minimum wage becomes higher than the Delaware minimum wage, the Delaware minimum wage would increase by \$1.00 above the federal minimum wage. In addition, effective July 1, 2014, the minimum wage would increase by a percentage equal to the percentage of Cost of Living Adjustment (COLA) as determined periodically under the federal Social Security Act, with the increase in the hourly rate being effective 90 days after the effective date of the corresponding increase in federal Social Security benefits.

This Bill was signed into law by the Governor on January 30, 2014.

House Bill No. 167 – "AN ACT TO AMEND TITLES 19 AND 29 OF THE DELAWARE CODE WITH REGARD TO EMPLOYMENT PRACTICES" (also known as "ban the box" bill)

Synopsis: This Bill would prohibit a public employer from inquiring into or considering the criminal record, criminal history or credit history or score of an applicant before it makes a conditional offer to the applicant. It would permit inquiry and consideration of criminal background after the conditional offer has been made. The Bill specifies that once a background check is conducted, an employer shall only consider felonies for 10 years from the completion of sentence, and misdemeanors for 5 years from the completion of sentence. Further, employers are required to consider several enumerated factors when deciding whether to revoke a conditional offer based on the results of a background check. Police forces, the Department of Corrections and other positions with a statutory mandate for background checks are excluded from these provisions. The Bill also requires contractors with State agencies to employ similar policies where not in conflict with other State or federal requirements.

This Bill has passed the House and is currently assigned to the Senate Industrial Relations Committee.

Karen Brewington, Director of Human Resources, advised that this is the same practice that the County currently follows. She explained that for anyone that an offer of employment is extended to, there is a condition of employment pending a criminal background check and a drug and alcohol test.

Mrs. Brewington stated that she met with Mr. Lawson and Mr. Godwin and they discussed the proposed legislation and that their recommendation is that the County is in favor of this Bill as it relates to not disqualify a person from applying for a position or interviewing for a position (if they qualify for that position). However, it is their recommendation to strike the language in the legislation that relates to the 10 year and 5 year time periods.

## Legislative Update (continued)

The Council stated its position to oppose the proposed legislation; however, it was noted that, if Mr. Godwin sees the legislation is moving forward, the Council supports an amendment to the Bill removing the 10 year and 5 year restrictions.

Senate Bill No. 159 - "AN ACT TO AMEND TITLE 17 OF THE DELAWARE CODE RELATING TO OUTDOOR ADVERTISING AND SIGNAGE"

Synopsis: This legislation provides clarification with respect to the placement, installation and maintenance of gateway signs to boundaries of political subdivisions and established non-incorporated areas of the State. (Signs would be put up by DelDOT.)

This Bill has passed the Senate.

Lawrence Lank, Director of Planning and Zoning, stated that he does not have a problem with the proposal.

**House Bill No. 243** – "AN ACT TO AMEND TITLE 25 OF THE DELAWARE CODE RELATING TO AGRICULTURAL LEASES"

Synopsis: Currently possession actions involving rental of residential or commercial property fall within the exclusive jurisdiction of the Justice of the Peace Court. There is no clear statement of jurisdiction for agricultural leases, though the possession issues are similar. This legislation provides that the Justice of the Peace Court has exclusive jurisdiction over agricultural lease matters and requires that service of process for any such action shall be provided by either personal service or certified mail, return receipt requested.

Mr. Godwin noted that this legislation will place agricultural leases under the Justice of the Peace Court where all other leases are.

<u>House Bill No. 159</u> – "AN ACT TO AMEND TITLE 15 OF THE DELAWARE CODE RELATING TO ELECTIONS"

Synopsis: This Bill prohibits a person from running as a candidate for more than one state, county or municipal office in the same election.

At the January 28<sup>th</sup> Council meeting, it was the consensus of the majority of the Council members to support this legislation.

This Bill has passed the House and was released from the Senate Administrative Services Committee on January 30<sup>th</sup>.

Legislative Update (continued) Mr. Godwin advised that the General Assembly is now out of session until March 18<sup>th</sup>.

Mr. Godwin reported that on Tuesday, February 11<sup>th</sup>, he will be attending the Wetlands Advisory Committee meeting.

Mr. Moore read the rules of procedure of zoning hearings.

Public Hearing/ C/U No. 1975 A Public Hearing was held on the Proposed Ordinance entitled "AN ORDINANCE TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR AUTO REPAIR AND SALES TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN CEDAR CREEK HUNDRED, SUSSEX COUNTY, CONTAINING 1.06 ACRES, MORE OR LESS" (Conditional Use No. 1975) filed on behalf of Ronald and Susan Berwick. (Tax Map I.D. 3-30-15.00-20.01)

The Planning and Zoning Commission held a Public Hearing on this application on January 9, 2014 at which time action was deferred. On January 23, 2014, the Commission recommended that the application be approved with 11 conditions.

(See the minutes of the Planning and Zoning Commission dated January 9 and 23, 2014.)

Lawrence Lank, Director of Planning and Zoning, read a summary of the Planning and Zoning Commission's Public Hearing.

The Council found that the applicants, Ronald and Susan Berwick, were in attendance. Mr. Berwick stated that they are trying to lease the property out and their lessee may be interested in buying it; that they are trying to get their estate in order; that the lessee wishes to lease the property for an

Public Hearing/ C/U No. 1975 (continued) auto mechanic shop; that they have a lease with the lessee with a condition that the Conditional Use is approved; and that the site was previously the site of an auto repair shop with a few cars for sale.

Ed Rothling (Lessee) of Milton stated that he is interested in a used car sales and mechanic business; that there may be 15 cars or less; and that any noise will be for the compressor and contained within the building;

Mr. Cole expressed concern with the number of cars (up to 15) that may be placed on the site for sale.

In response to questions, Mr. Lank stated that the Code requires that the display of vehicles will be at least 25 feet from the property line; that the display area does not have to be paved; and that the driveway/parking area for the shop will have to be paved if required customer parking exceeds 10 vehicles.

There were no public comments and the public record and Public Hearing were closed.

M 065 14 Adopt Ordinance No. 2336 (C/U No. 1975) A Motion was made by Mrs. Deaver, seconded by Mr. Phillips, to Adopt Ordinance No. 2336 entitled "AN ORDINANCE TO GRANT A CONDITIONAL USE OF LAND IN AN AR-1 AGRICULTURAL RESIDENTIAL DISTRICT FOR AUTO REPAIR AND SALES TO BE LOCATED ON A CERTAIN PARCEL OF LAND LYING AND BEING IN CEDAR CREEK HUNDRED, SUSSEX COUNTY, CONTAINING 1.06 ACRES, MORE OR LESS" (Conditional Use No. 1975) filed on behalf of Ronald and Susan Berwick, with the following conditions:

- A. The hours of operation shall be from 8:00 a.m. to 6:00 p.m. Monday through Saturday.
- B. One lighted sign, not to exceed 32 square feet per side, shall be permitted.
- C. Security lighting shall be downward screened and shall be directed away from neighboring properties and roadways.
- D. Any dumpsters shall be screened from view of neighbors and roadways. The dumpster locations shall be shown on the Final Site Plan.
- E. All repairs shall be performed indoors. No automobile parts shall be stored outside.
- F. No junked, unregistered or permanently inoperable vehicles or trailers shall be stored on the site.
- G. No more than 15 cars shall be displayed for sale on the site at any one time. No more than 5 additional vehicles may be parked outside the building in preparation for the sales lot.
- H. All display areas, parking and storage areas shall be clearly depicted on the Final Site Plan.
- I. No more than 5 vehicles waiting for service or parts may be parked outside.

K. The Final Site Plan shall be subject to the review and approval of the Sussex County Planning and Zoning Commission.

IBRWF Expansion Phase 2B/ Solids Handling Rebid/ Contract 12-17 Michael Izzo, County Engineer, presented the bid results and the proposed bid award for the Inland Bays Regional Wastewater Facility Expansion (IBRWF) Phase 2B, Solids Handling Rebid, Contract 12-17. He explained that this is for the scope of work which will start the process of constructing new sludge handling facilities; this is the first step of moving towards a Class A sludge. Currently, it is a liquid sludge at the Inland Bays facility and they want to move to a dry sludge.

Mr. Izzo reported that bids were originally opened on June 19, 2013 but due to higher than expected costs, all bids were rejected at that time. The Council gave the Engineering Department direction to take steps to increase the bidder pool since only two bids were received. To that end, the Department reached out to approximately 20 general contractors. Additionally, the Department met with the two contractors who originally bid the project and as a result, the County received a number of value engineering proposals. By incorporating those suggestions into the bid package, a reduction of \$122,000 was received compared to previous bids.

Mr. Izzo noted that only 2 bids were received when the project was rebid:

**Bearing Construction, Inc.** 

Sudlersville, Maryland \$3,017,850.00

**Daisy Construction** 

Newport, Delaware \$3,407,850.00

(The previous low bid was \$3,140,450.00.)

Mr. Izzo noted that although only two bids were received, five packets were picked up. He also noted that two of the companies (JJID and Daisey) combined their bid. Mr. Izzo reported that JJID had bid the project back in June and the combination of them going together was \$300,000 higher than what they bid in June.

Mr. Phillips questioned the fact that the Engineer's Estimate was not listed on the Bid Results information sheet. In response to the question, Mr. Izzo stated that the Engineer's Estimate for the project is \$2,750,000.00.

IBRWF Expansion/ Phase 2B Solids Handling Rebid/ Contract 12-17 (continued) Mr. Izzo noted that the County has \$850,000 in USDA grant funding that can be used towards the project; however, the funding must be expended by September 30, 2014.

Mr. Phillips questioned the delay in rebidding the project; questioned why the project is now a rush; stated that there are still contractors that wish to bid on the contract; stated that the engineer's estimate was not previously provided which is a staple of bids that Council considers; stated that the estimate is conveniently missing this time; expressed concern that the project came in at \$250,000.00 over the Engineer's Estimate and therefore, it seems it would be worth the effort to rebid the contract; and questioned the new information regarding the JJID and Daisey bids (first bid process).

Mr. Izzo responded that a flexible start date was set up for the contractors; that Bearing said that they would be ready to start on May 1<sup>st</sup>; that there was not a rush to award the project; that the Engineering Department would like to start getting organized for the project especially since they have met with USDA regarding the grant funding and its expiration date; that he did provide information relative to the previous bid; that he would be sure to provide the engineer's estimate in future bid results; and he questioned who the interested contractor is. Mr. Izzo stated that his recommendation is to award the contract. He noted that if the Council wishes, the contract can be rebid.

That there are limited times during the year when liquid sludge can be applied.

Mrs. Deaver stated for the record that she objects to Mr. Phillips' comments to the County Engineer that the engineer's estimate was conveniently missing.

Angola North Expansion Area Extension John Ashman, Director of Utility Planning, requested permission to prepare and post notices for the Angola North Expansion Area. The Engineering Department recently completed a planning study for the area based on a Resolution that was presented and approved by the County Council on May 25, 2010, where they used a planning study grant from the then Cleanwater

of the Angola North Expansion Area (continued) Advisory Council and contracted with CABE Associates to complete the plan. The plan has been reviewed and there are multiple projects in the area in various stages of design, i.e. Pelican Landing and the Boat Hole at Love Creek; there is also an existing commercial parcel which is Peddlers Village that is interested in a regional option for dealing with their future wastewater disposal needs. In addition, the Engineering Department has received a request from the existing subdivision known as Love Creek Woods for the County to explore the cost and possibility of providing County sewer service for their community. Additionally, the Department has had several inquiries throughout the years for Fox Hollow and some reports of failing septic systems there. Mr. Ashman stated that, with Council's approval, a Public Hearing will be scheduled.

Goslee Creek Planning Study Grant John Ashman, Director of Utility Planning, presented a request to submit a Regional Wastewater Planning Area Grant application to the Water Infrastructure Advisory Council to assist in funding the Goslee Creek Planning Study. Mr. Ashman stated that, as presented on January 14th, there are multiple projects in the area in various stages of design that are interested in a regional option of dealing with their future wastewater and treatment and disposal. Mr. Ashman noted that the County Council approved the proposal from Whitman, Requardt & Associates in the amount of \$167,215.00 to perform the planning study as part of the North Coastal Contract and the study will confirm the size of the drainage basin, what new projects and/or existing homes can be served and how they can be served, and includes a plan for how these parcels will be served with estimated costs for the infrastructure to provide that service. The grant monies that they would be applying for are based on a 50 percent match; the maximum is \$150,000. Mr. Ashman noted that the Department is applying for \$83,607.50.

Potential Closure of FAA Navigation Aid Jim Hickin, Airport Manager, updated the Council on a FAA proposal to decommission a navigation aid used by the Sussex County Airport which he believes will have a negative impact on the airport. He stated that the FAA owns and operates the Waterloo VOR, a ground based navigation aid (a radio transmitter) located in the Broadkill Beach area. The facility has structural problems caused by recent flooding and the FAA would like to close it for financial reasons. However, the VOR provides navigation guidance for instrument approaches to the County Airport's main runway. These approach procedures would go away and pilots would be required to use the satellite-based approaches (GPS) to the runway. Unfortunately, not all aircraft have GPS capability. These aircraft would not be able to land at the airport during low visibility conditions.

Mr. Hickin noted that there is a consensus of the Airport Advisory Committee to oppose the closure.

The FAA is asking the public for comments regarding the proposed closure; comments are due by Friday, February 14<sup>th</sup>. Mr. Hickin stated that he has prepared a letter of response and that the proposed letter was included in Council's packets. He stated that the letter will be mailed unless the Council directs otherwise.

The Council agreed that letters should also be sent to the County's congressional delegation to solicit their help and support and to let them know the importance of this issue and the impact it would have on the County's Airport.

Mr. Cole suggested that the County find out additional information including what the costs are and that possibly, the County may be able to find some funding to repair/maintain the VOR.

At the February 11, 2014 Council meeting, I will be discussing the timing and process of our insurance procurement and the role our consultant plays in our insurance needs. This will be "informational only" and no action is required by Council. The insurance bids will be brought back to Council for recommendation and approval in June.

Every three years, the County rebids its insurance package with the help of our consultant, Insurance Buyers' Council, Inc. (IBC). This process includes our vast insurance needs that include: automobile, general liability, law enforcement, public officials, employment practices, workers compensation, umbrella, property, boiler & machinery, outfall pipeline, crime, and airport.

Our consultant will provide the following services so that the County may prepare a competitive proposal and make recommendation to Council:

- 1. Gather comprehensive property records and updated loss information
- 2. Prepare the RFP
- 3. Analyze the responses
- 4. Provide written analysis with coverage and cost comparisons
- 5. Make recommendations

Competitive Proposal Procedure

Dear Ms. Jennings:

Per our telephone conversation on Tuesday, we agreed to submit a proposal for conducting a competitive proposal procedure on the County's behalf. We have been conducting these procedures for Sussex County since 1983 and look forward to the opportunity to once again assist you.

We propose that this procedure consist of two projects. Due to the County's continued operational growth and changes, we are proposing to conduct a 1 day risk management audit of the County's exposures. The audit interviews assist us in keeping current with changes in the County's operations and exposures and serves to bring risk management into focus for County staff. As we use the information gathered in the audit not just for the management of the competitive proposal procedure, but any subsequent consulting work as well, we feel this should be a separate project in and of itself.

In the audit project, we will identify and analyze your property and liability insurable exposures to accomplish the following:

- A. Interviews with you and other personnel to update our records on your property and liability insurable exposures:
- B. Gather information to prepare comprehensive property and liability insurance specifications; and
- C. Discuss with you your goals and objectives for the competitive proposal procedure and your ongoing risk management program.

We estimate that this will take 1 day on-site and one day of preparation. While it is anticipated that this will be conducted under our continuous service agreement currently in place, we would agree to limit the fee chargeable for this project to \$2,800 plus expenses outlined on Exhibit II. The audit fee in 2011 was \$2,725.

While a risk management audit is recommended, we do not require the audit be conducted in order to prepare the RFP. We can prepare the RFP based on information on file as well as the property, mobile equipment, auto and driver schedules referenced later in this proposal.

Once the audit is completed (or waived) we would commence the second phase, the competitive proposal procedure process. In this project, we will prepare a Request for Insurance Proposals (RFP), supervise the competitive quotation procedure and review the proposals.

In preparation of the RFP, we will contact your producer (Pratt) to obtain additional technical information concerning your policies including updated loss information. A draft RFP will then be prepared for your review and approval. Once approved, the RFP would be made available on the County's website to interested producers and insurers. The RFP will contain requests for alternate coverages, limits and retentions based on our exposure analysis and your needs and objectives.

Following the distribution of the RFP, we will recommend insurer assignments on your behalf, wherein each interested producer will be instructed to submit a producer questionnaire that lists, in order to preference, five insurers per line of coverage from which it intends to solicit proposals. Together with you, we will then assign insurers to the producers in as equitable a manner as possible, but at your sole discretion. This will preclude any one producer from monopolizing the property and liability insurance marketplace.

We will supervise the competitive quotation procedure from the standpoint of being available to answer any technical questions that may arise concerning the intent of the terms outlined in the RFP. The County will be responsible for coordinating insurer and producer on-site inspections and interviews, verification of underwriting data and completing all applications.

Following our review of all the proposals received, we will provide you with a written analysis together with coverage and cost comparison exhibits and specific recommendations concerning the placement of insurance to be effective July 1, 2014.

Our analysis of the quotations would be based on the following criteria:

- Scope of coverage;
- Insurer financial rating;
- Insurer, producer and (if applicable) third party administrator services; and
- Reasonably anticipated net cost.

We will then be available to personally discuss our recommendations with you and the County Council. Delivery and discussion of the recommendation letter and exhibits will complete the services to be performed under this project. Our timeline for the procedure is outlined in Exhibit II

I will be the Principal Consultant for both projects. Additional professional staff will be involved in the actual preparation of the RFP and the analysis of the proposals.

Our fee for the competitive proposal procedure in 2008 and 2011 were \$17,950 and \$19,600 respectively. However, in 2011 we were 50% over fee for the process due in part to multiple loss sensitive workers compensation rating plan proposals requiring more extensive cost estimate analysis, challenging loss experience and reduced involvement in the day to day insurance affairs of the County. In addition to loss sensitive workers compensation proposals, recent adverse loss experience for public officials' liability could further complicate our review. For these reasons, we are proposing a fee of \$25,500 for conducting the competitive proposal procedure process, plus any necessary expenses. Expenses that would be charged in addition to our professional fees are specified in Exhibit II.

This fee is contingent on utilizing the property statement of values, vehicle, mobile equipment and driver listings maintained by Ms. Barry and Ms. Thompson, as provided. It is also contingent on the RFP seeking proposals for your existing property and liability insurance, other than individual public official bonds. Adding coverages to the RFP may necessitate an additional fee. This fee does not include consideration of "self-insurance" of your workers compensation obligations (applying to the Department of Labor to be a self-

insured) as this would require an increased fee. We propose that a portion of the fee would be billed monthly based on time incurred in the prior month, with any balance of the maximum billed at the completion of the project.

The proposed fee contemplates no more than five complete property and liability insurance proposals. In the event that more than five proposals are received, IBC reserves the right to charge for our analysis and recommendations concerning any proposals in excess of five at \$150 per hour. In the last three competitive proposal procedures, you have not received more than three complete submissions. We will contact you for prior approval before analyzing more than five proposals.

We certainly hope that our proposed terms are satisfactory to you. If you have any questions, please do not hesitate to contact us. We look forward to continuing our service on your behalf.

## NDS ROUND GRATE WITH SEWER & DRAIN ELBOW

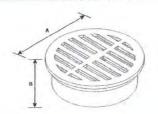

Doug Marvil, President of the Laurel Historical Society, has joined me in writing this request to you and Sussex County Councilman Vance Phillips. The Laurel Heritage Museum located in the renovated old Laurel train station is a joint project of the Town of Laurel and the Laurel Historical Society. The Town assists with the operation of this building by paying for the utility operating costs. The Laurel Historical Society operates the museum and generates operational and maintenance fund from grants and donations. The Museum also houses the Laurel Chamber of Commerce office. This allows visitors to visit the museum daily. The Town and the Laurel Historical Society have received many favorable comments from visitors about the quality of the exhibits. Visitors are also able to pick up information about tourist attractions in the Laurel area.

The old yellow paint on the building wood trim needs to be repainted. Since the paint, which is peeling in many places, is lead based the painting contractor needs to be certified in the handling of lead based paint.
